

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://onekumu.com>, and OneKumu Corporation and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to OneKumu Corporation include <https://onekumu.com> and OneKumu. The OneKumu website is a Technology Consulting site. By using the OneKumu website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, OneKumu may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

We do not collect any personal information about you unless you voluntarily provide it to us.
